## Three partner universities in France

1. IAE Gustave Eiffel – Université Paris-Est Créteil (UPEC).
  2. Université de Strasbourg.
  3. Institut d'Études Politiques (IEP) Strasbourg.

- All exchange opportunities are open to both Bachelor and Master students.

## IAE Gustave Eiffel – Université Paris-Est Créteil

- ERASMUS agreement exists with the IAE Gustave Eiffel School Of Management (= a faculty of the Université Paris-Est).
- Créteil is located in the south-east of Paris (metro station: Crétail Université, M8).
- Number of spots: 2 for 10 months (2 semesters) each: can be split into 4 spots for 5 months.
- Focus of courses is on business and management (study programs offered are « Management International », « Controlling and Audit » or « Gestion d'entreprise », among others).
- More specialized master programs, e.g. « Management du Sport », « Management des Etablissements de Santé », « Géomarketing » etc. (see [Website](#)).
- Course offer comprises both English and French courses (English courses mostly in the bachelor program « Management International » and in the master program « International MBA »).

Beispiel aus dem Master « Management du Sport »

- Rich offer of cultural and leisure activities in Paris, large number of sports classes at the university (> 30 courses) and different activities organized by the BDE (Bureau des étudiants).

# Université de Strasbourg

- Number of spots: 6 for 5 months (1 semester).
- Université de Strasbourg is one of France largest universities (52.000 students): broad offer of cultural, sport and leisure activities.
- Study programs both in economics and business administration (as well as in related fields):
  - Bachelor « Économie et Gestion » with focus areas Analyse économique, Économie et management, Économie quantitative, Gestion, International Economics and Management und Santé.
  - Master « Analyse et politique économique », « Gestion de la production, logistique, achats », « Management de l'innovation », « Management et commerce international », « Monnaie, banque, finance, assurance ».
- Courses are mainly in French, but there are also some courses in English (e.g. within the focus area « International Economics and Management »).

Master « Management et commerce international »

- Campus university (other than FAU): all faculties, libraries and central service units are within walking distance of each other → „uni feeling“.
- Strasbourg is an international city: university buddy programs, „Café des langues“, etc.

# Institut d'Études Politiques (IEP) Strasbourg

- Number of spots: 6 for 10 months (2 semesters) each: can be split into 12 spots for 5 months.
- IEP is a « Grande École » (French top university): regular students need to go through a competitive process to study at IEP.
- Study program at IEP is interdisciplinary and contains, among others, courses in the area of economics, sociology, history, law and international relations (→ possibility to take courses you cannot take at WiSo in Nuremberg).
- Regular IEP students spend their 3rd year of studies abroad:
  - Students are generally very open towards international exchange students.
  - No regular course offer in the 3rd year (i.e. 5th and 6th Bachelor semester): Bachelor exchange students need to take courses from either the 2nd or the 4th year.
- IEP is part of the Université de Strasbourg, i.e. the university's sports and leisure programs, student clubs etc. are also open to IEP students.

# Institut d'Études Politiques (IEP) Strasbourg

- Courses are mainly in French; there are only few courses that are held in English.
- Strong „European“ orientation: possibility to do internships at the European parliament during the semester or to participate at the « Semaine Européenne », which is organized by the IEP.
- Focus areas in the 4th and 5th year of study (= master years): Administration publique, droit européen, études européennes et internationales, Finance, Relations internationales, Science Politique.
